ELEMENTARY CONTRACT (1ST THROUGH 6TH GRADE)

This agreement is made and entered into between Dynamite Montessori, Inc., hereinafter known as the "School," and _____, hereinafter known as the "Parents." Parents contact information: Email: _____ Cell #: _____

The School hereby accepts _____ as a pupil for the school year August 1, 2017 through May 25, 2018. Pupils are enrolled for the entire school year or for the remainder of a school year if enrolled after the opening date.

Pro-rated allowances will be made if the child is accepted after the first week of the school year. Monthly tuition rates will remain the same for the school year. Tuition for the first and last month is due in full before first day of attendance. **If a pupil is withdrawn before the end of the school year, the last month pre-paid tuition deposit will be forfeited.** The School reserves the right to terminate this contract if the Parents fail to keep their financial obligations, if the child's behavior warrants such action, if attendance becomes irregular, or if parents are not supportive of the policies of Dynamite Montessori. If parents dis-enroll their child due to a move more than 10 miles away from our school the last month's pre-paid tuition may be refunded.

Tuition rates are as follows: Monday through Friday

- Tuition is \$780.00/month
- One time, non-refundable registration fee of \$100.00
- Annual AMI membership fee of \$20.00
- Recorder book fee (TBA)
- First and last month's tuition is due upon enrollment
- Standardized testing fee of \$50.00 for 3rd, 4th, 5th, & 6th graders. \$20.00 for 2nd graders.
- Siblings enrolled concurrently, **full day-five days a week**, will receive a 10% discount.
- School hours are 8:00 am to 4:00 pm Monday through Friday. Elementary children may enjoy a.m. and p.m. gratis daycare until 5:00 p.m.
- A \$25.00 charge will be assessed for late pickup (after 5:30 p.m.)
- Tuition is due by the 1st of the month, and considered late after the 5th day of the month. A late fee of \$25.00 will be charged if tuition is paid after the 5th.
- No tuition shall be refunded due to the child's absence from school, holidays, teacher in-service days or school breaks.

DMS primarily follows the Cave Creek Unified School District (CCUSD) calendar for all breaks and school closings. Please refer to the school calendar on our web-site <http://www.DynamiteMontessori.com>.

Included in tuition are sports, dance, music, computer and Spanish instruction. Sports, music or other special classes are held every day. These classes and all class hikes are a mandatory part of instruction and are not considered optional. Parents are required to purchase sports equipment as needed and are expected to participate in transporting children on field trips. Parking fees for hikes will be billed to parents (\$3 to \$5/hike).

School uniforms are mandatory. Uniforms consist of khaki pants, shorts or skirt with white, light blue or navy polo embroidered with the DMS logo as provided by DMS approved supplier. Xavier plaid skirts are also acceptable. If a child arrives at school out of uniform, DMS will provide the required articles and bill the parents for the items accordingly.

One security gate card will be supplied to each parent, free of charge. Replacement or additional gate cards can be purchased for \$25.00 each. At such time as the child is no longer in attendance at Dynamite Montessori the provided gate cards must be returned to the school or a charge of \$25.00 per card will be billed to the Parents. Cards which have been purchased must also be returned for which the school will provide a \$25.00 per card redemption.

When a child is absent it is the responsibility of the parent to consult with the teacher concerning make up work.

Elementary students are assigned homework. Parents agree to assist their child with assignments and check record book **weekly**. E-mail is the primary means of communication between the school and parents. Parents agree to regularly check and participate in e-mail communication with the school.

New parents agree to attend a 2.5 hour Saturday workshop on August 19, 2017 from 9 AM to 11:30 PM. Daycare is provided.

Parents are also required to attend one parent-teacher conference and one parent education meeting each semester.

New parents agree to be present at our first general meeting on August 23rd from 4:15 to 5:00 PM. We will discuss policies, philosophy, curriculum, and events.

Parents understand that the elementary program is a **3 year cycle** and intend to keep their child at Dynamite Montessori through grade 3.

The School reserves the right to terminate this contract if the Parents fail to fulfill their financial obligations; the child's attendance becomes irregular; or, in the sole judgment of School management, either the Parents or the child become a disruption to the School's education and administrative processes or a threat to the emotional or physical well-being of others.
