This agreement is made and entered into between Dynamite Montessori, Inc., hereinafter known as the "School," and _____, hereinafter known as the "Parents."

The School hereby accepts _____ as a pupil for the school year August 7, 2008 through May 22, 2009. Pupils are enrolled for the entire school year or for the remainder of a school year if enrolled after the opening date.

Pro-rated allowances will be made if the child is accepted after the first week of the school year. Monthly tuition rates will remain the same for the school year. Tuition for the first month and last month is due in full before first day of attendance. If a pupil is withdrawn before the end of the school year, the last month pre-paid tuition deposit will be forfeited. The School reserves the right to terminate this contract if the Parents fail to keep their financial obligations or if the child's behavior warrants such action.

Tuition rates are as follows: Monday through Friday

Full Day schedule 8:00 am to 4:00 pm - \$725.00/per month

Half Day schedule 8:00 am to 1:00 pm - \$600.00/per month

Daycare is available from 7:30-8:00am and 4:00-5:30pm at \$8.00/hour.

A \$25.00 charge will be assessed for late pickup.

Siblings enrolled concurrently, **full day – five days a week**, will receive a 10% discount. Full Day siblings will not be charged for daycare.

Tuition includes Spanish and soccer instruction.

Tuition is due by the 1st of the month and considered late after the 5th day of the month. A late fee of \$25.00 will be charged if tuition is paid after the 5th. No tuition shall be refunded due to the child's absence from school, holidays, teacher in-service days or school breaks. DMS primarily follows the Cave Creek Unified School District (CCUSD) calendar for all breaks and school closings. One security gate card will be supplied to each parent, free of charge. Replacement or additional gate cards can be purchased for \$25.00 each.

To enroll, a one-time, non-refundable registration fee of \$100.00 and an annual AMI membership fee of \$14.00 are required in addition to the first and last month's tuition. All returning students are required to pay the last month pre-paid tuition deposit and AMI fee for the new school year.

Parents are responsible for checking their child's cubbies each week and taking work home.

E-mail is the primary means of communication between the school and parents. Parents agree to regularly check and participate in e-mail communication with the school.

Parents are required to attend one parent education/conference meeting per semester.
